



RELEASE AND AGREEMENT DOCUMENT FOR MINORS

Hearthstone is a free-to-play online card game from Blizzard Entertainment Inc. Mark Wilson, assisted by some volunteers, (collectively **the Released Parties**) have organized casual social Fireside Gatherings (**the Events**) for the benefit of Hearthstone players, new or experienced, in the Kitchener-Waterloo-Cambridge-Guelph area. Players are expected to bring their own Hearthstone-compatible device (laptop, tablet, or phone) with WiFi network capability. Attendance fee is a modest cash donation, drinks and snacks are available for modest cash amount, or participants can bring their own.

This release and agreement document applies to the following minor (**the Participant**):

RELEASE OF LIABILITY, WAIVER OF CLAIMS, ASSUMPTION OF RISKS AND INDEMNITY AGREEMENT

In consideration for allowing the Participant to attend and participate in the Events of the Released Parties, I hereby warrant and agree:

1. I am the parent/guardian having full legal responsibility for decisions regarding the Participant; and
2. I am familiar with and accept, on behalf of myself and the Participant that there may be risks in attending the Events (stairs, etc.); and
3. I have satisfied myself and believe that the Participant is physically, emotionally and mentally able to participate in the Events; and
4. I understand, and will instruct the Participant, that all applicable rules for participation must be followed and that at all times the sole responsibility for personal safety remains with the Participant; and
5. I will immediately remove the Participant from participation if at any time I sense or observe any unusual hazard or unsafe condition or if I feel that the Participant has experienced any deterioration in his/her physical, emotional or mental fitness; and
6. I authorize the Released Parties to consent to emergency medical treatment in accordance with the best interests of the Participant, should I not be present at the relevant time to grant consent myself.

I understand and agree, on behalf of the Participant, his/her heirs, assigns, personal representatives and next of kin, myself, my heirs, assigns, personal representatives and next of kin that my execution of this document constitutes:

1. AN UNQUALIFIED ASSUMPTION OF ALL RISKS associated with participation in the Events by the Participant even if arising from negligence or gross negligence, including any compounding or aggravation of injuries caused by negligent first aid operations or procedures, of the event organizer, the event venue, and any persons associated therewith; and
2. A FULL AND FINAL RELEASE AND WAIVER OF LIABILITY AND ALL CLAIMS that I have or may in the future have against the Released Parties from any and all liability for any loss, damage, injury or expense that the Participant may suffer, or that his/her next of kin may suffer as a result of his/her use of or presence at, the Events, due to any cause whatsoever, INCLUDING NEGLIGENCE, BREACH OF CONTRACT, OR BREACH OF ANY STATUTORY OR OTHER DUTY OF CARE, INCLUDING ANY DUTY OF

CARE OWED UNDER THE RELEVANT OCCUPIERS LIABILITY ACT OR ANY OTHER RELEVANT STATUTES, on the part of the Released Parties; and

3. AN AGREEMENT NOT TO SUE the Released Parties for any loss, injury, costs or damages of any form or type, howsoever caused or arising, and whether directly or indirectly from the participation of the Participant in the Events; and
4. AN AGREEMENT TO INDEMNIFY, and to SAVE and HOLD HARMLESS the Released Parties from any litigation expense, legal fees, liability, damage, award or cost, of any form or type whatsoever, they may incur due to any claim made against them or any one of them whether the claim is based on the negligence or the gross negligence of the Released Parties or otherwise; and

In further consideration for allowing the above named Participant to attend and participate in the Events, the undersigned does hereby give the Released Parties permission to capture and/or record the Participant's name, image, likeness, persona, photograph, or voice, in any media and/or technology now known or later developed. Such use of her name, image, likeness, persona, photograph, or voice can be used throughout the world for educational, commercial, trade, or any other lawful purpose.

ASSUMPTION OF RESPONSIBILITIES

1. Responsibility for Damages: The undersigned does hereby agree to assume full responsibility for any and all damages that are caused by the above named Participant while attending the Events. The Release Parties will be reimbursed the total cost of repairing any damages to walls, ceilings, floors, lights, etc. Any chairs, tables, equipment, appliances etc. which are damaged must be replaced with a like item.
2. Responsibility for Transportation: The undersigned does hereby agree to assume full responsibility for transportation of the Participant to and from the Events.
3. Responsibility for Medical or Special Needs: The undersigned does hereby agree to provide in confidence to the event organizers, any necessary and/or critical information regarding medical or special needs of the Participant (allergies, etc.).

I HAVE READ AND UNDERSTAND THIS FULL AGREEMENT, AND I AM AWARE THAT BY SIGNING THIS AGREEMENT I AM WAIVING CERTAIN SUBSTANTIAL LEGAL RIGHTS WHICH The Participant, HIS/HER HEIRS, NEXT OF KIN, EXECUTORS, ADMINISTRATORS AND ASSIGNS AND I MAY HAVE AGAINST THE Released Parties.
